OUR MISSION

To lead the fight to prevent the spread of **HIV and AIDS** and to **empower** people in Central Indiana affected by HIV and AIDS to move forward each day with **dignity**.

We work to reduce the number of new HIV infections through a full-service approach—finding those who are HIV positive, providing them with the supportive services that they need to be healthy, and linking them to medical care to reduce their HIV viral load. This not only makes them healthier—it also reduces the likelihood of transmission of the HIV virus when combined with safe sex practices, directly resulting in fewer new infections in our community. The addition of an on-site IU LifeCare medical clinic in 2012 helps us do just that. By providing immediate and convenient access to primary medical care, the clinic allows our clients to get back to the important part of life: living.



STOPPING HIV/AIDS IN ITS TRACKS

PREVENTION

When **JOHN** tests negative for HIV, he is engaged in **prevention education** and **ongoing testing** to reduce his risk of contracting HIV. Since **JANE** tests HIV+, she will be linked with the **care** she needs, encouraged to return frequently for **STD tests**, and engaged in **prevention education** to reduce her risk of spreading HIV.

HIV & STD TESTING

We provide free and confidential testing by state-certified testers both on-site at the Joseph F. Miller Testing Center and at various satellite locations. We test for HIV, pregnancy, and STDs, including syphilis, gonorrhea, chlamydia, and trichomoniasis.

PROJECT CORE

Project CORE is an innovative outreach effort that reduces transmission of HIV among racial and ethnic minorities recently released from incarceration.

TEEN DAMIEN

Our Teen Damien program empowers youth to be their own advocates. We emphasize positive sexual health, open discussion, and peer advocacy.

COMPREHENSIVE RISK COUNSELING (CRCS)

Through CRCS, anyone infected with or affected by HIV and AIDS can utilize risk-reduction support in a sensitive and culturally competent environment.

LINKAGE TO CARE





CARE COORDINATION

Care Coordination is comprehensive **case management** that connects **JANE** to the resources she needs to live a **long, fulfilling life**. Now **JANE** can access insurance, housing, support groups, counseling, a food pantry, transportation, medical services, and **much more**.



ELIZABETH FROM FEARFUL TO EMPOWERED

When Elizabeth, 23, contracted HIV from her boyfriend, she was lost, frightened, and desperate. The mother of two had come to the U.S. from Zambia but never received permanent residency. The father of her children was abusive, but without legal citizenship, a job, family, or insurance, she was dependent on him. The once strong and outspoken young woman became fearful and controlled. She was terrified of being deported back to Africa, where she would likely die and her children would be orphans. Elizabeth didn't know where to turn.

Fortunately, The Damien Center's Care Coordination program was there. Our staff empowered Elizabeth and her children to escape the tyranny of her boyfriend, obtain insurance, life-saving medication, and health care, and apply for legal citizenship. That frightened young mother is now a legal U.S. resident with two happy children. Although hers has been a difficult journey, Elizabeth credits The Damien Center with giving her hope and confidence in herself. She now knows she can accomplish anything she sets her mind to.

COUNSELING

An increased emphasis on **mental health counseling** and **substance abuse counseling** means that clients like **JANE** are better equipped to stay healthy in the face of HIV. Our licensed counselors provide a supportive, client-centered approach so **JANE** can work toward self-sufficiency and holistic wellness.

MEDICAL CASE MANAGEMENT

A new program at The Damien Center in 2012, **medical case management** helps **JANE** navigate her medical needs. From setting up appointments with our on-site clinic to helping her adhere to HIV medications, **JANE'S** medical case manager is a direct support line for her medical needs.

OUR APPROACH

We offer a **holistic, one-stop-shop approach** to HIV care and prevention that focuses on **reducing HIV viral load** in our community.



MEDICAL CLINIC

Established in 2012, our on-site **IU LifeCare medical clinic** provides medical care right here at The Damien Center. **JANE** can meet with a nurse practitioner and manage her medical needs as well as use our pharmaceutical courier service to receive **medications**. The presence of the clinic allows The Damien Center to more accurately track the **HIV viral load** of our clients, a key indicator of health in the HIV+ population.





PROVIDING WRAP-AROUND SUPPORT



JANE AND JOHN ACCESS SUPPORTIVE SERVICES FOR HIV+ AND HIGH-RISK HIV- INDIVIDUALS.



FINANCIAL ASSISTANCE

Direct Emergency Financial Assistance (DEFA) helps **JANE** with short-term rent, utilities, incidentals, or other one-time emergencies that shouldn't happen again in the next year, like car repairs or glasses.



FOOD PANTRY

Meeting basic **nutritional needs** is critical for **JANE**, who is already facing an often debilitating health condition and must maintain **strong basic health** to fight her HIV infection. By accessing our **food pantry**, **JANE** can keep her body strong.

CAREER DEVELOPMENT

Our career development program helps **JANE** and **JOHN** prepare for and find employment, which helps them work toward **self-sufficiency** whether they're HIV+ or HIV-.



HOUSING ASSISTANCE

We believe that **housing is healthcare**. Stable, affordable housing offers the best opportunity for **JANE** and **JOHN** to access drug therapies, treatments, and supportive services that will enhance their **quality of life**. When both HIV+ and high-risk HIV- people are housed, they can better manage other needs and are able to become **healthy** and **self-sufficient**.

BILLY FROM HOMELESS TO HEALTHY

Billy, 43, came to us only after being hospitalized and in very poor health. On the verge of being discharged from the hospital, Billy would have been homeless and HIV+ without medication or a way to support himself. Instead, he came to The Damien Center, where he worked with our staff to obtain safe and stable housing so he could stay off the streets and on his medications.

Billy worked hard to put together his application materials—a letter of homelessness and proof of income—and even provided a medical history from the hospital. Billy began to take charge of staying in care and finding the housing he needed to stay safe and healthy. Today, Billy manages his income, stays on his meds, and meets with our staff to stay on track. Billy is now empowered to monitor his needs and make decisions to access the services he needs.



FUNDRAISING & EVENTS.



Everything we do at The Damien Center is provided completely **free of charge**. We rely on grants, donations, fundraising events, and volunteers to improve our community's health by empowering individuals affected and infected by HIV.

DINING OUT FOR LIFE

On April 26, 2012, more than 40 local restaurants donated 25% to 100% of their day's sales to The Damien Center. Here's how it worked: there were no codes, no special menus—diners only needed to eat! Our most successful **Dining Out for Life** yet, the event raised more than \$68,000 for The Damien Center and reached 10,000 local diners. In 2012, Red Lion Grog House, located in Fountain Square's historic Murphy Building, became the event's first Champion Restaurant, donating 100% of April 26 sales to The Damien Center!



