

COMMUNITY FOCUS

At The Damien Center, we offer a **comprehensive, one-stop-shop approach** to HIV care and prevention. Our programs and services help **reduce patients' HIV viral loads** (the amount of HIV in the body) and **increase CD4 levels** (the amount of healthy, immune-boosting cells in the body), **improving the health of clients and our community.**



PREVENT

STOPPING HIV IN ITS TRACKS

One in six people living with HIV are not aware of their status, yet 50% of new infections originate from this population. **TESTING & PREVENTION** aims to reach those who do not know their status, reduce the spread of HIV and other STIs, and improve the health of our community through education and outreach.

HIV & STD TESTING

We provide free and confidential testing by state-certified testers both on site at the Joseph F. Miller Testing Center and at various satellite locations. We test for HIV, pregnancy, and STIs, including syphilis, gonorrhea, chlamydia, and trichomoniasis.

PROJECT CORE

Project CORE is an innovative outreach effort that reduces transmission of HIV among racial and ethnic minorities recently released from incarceration.

PREVENTION OUTREACH



In addition to outreach testing at satellite locations, prevention outreach includes education that empowers individuals to take control of their sexual health.

COMPREHENSIVE RISK

COUNSELING (CRCS)

Through CRCS, anyone infected with or affected by HIV and AIDS can utilize risk-reduction support in a sensitive and culturally competent environment.

LINKING CLIENTS WITH CARE

With 10,000 people living with HIV right here in Indiana, our HIV+ clients need resources and support as they overcome barriers to care. **LINKAGE TO CARE** and **CARE COORDINATION** work to connect clients with the care they need.

LINKAGE TO CARE

A new program in 2012, Linkage to Care provides intensive and individualized support to people living with HIV. Those newly diagnosed have 24-hour access to support via phone and text to ensure successful entrance into care. The program also targets HIV+ individuals who have been out of care for a year or more and provides the support they need to identify and eliminate individual barriers to care. L2C emphasizes:

- Reengaging clients into care
- Eliminating barriers to care
- Transportation to medical appointments
- Reminder calls to take medication
- Youth outreach

CARE COORDINATION

Care Coordination is comprehensive, specialized case management that connects patients to the resources they need to live long, fulfilling lives. Bilingual staff and Kids Club help meet the varied needs of all patients. Our health care providers assist patients with:

- Prescription drugs
- Health insurance
- Medical/clinical care
- Vision/dental care




CARE FOR | ENSURING WHOLE-BODY WELLNESS

For those living with HIV, working toward holistic wellness requires a comprehensive approach. **MEDICAL SUPPORT** and **MENTAL HEALTH SERVICES** help patients reduce the amount of HIV and increase the amount of healthy cells in the body while also emphasizing mental health, individualized support, and overall wellness.

MEDICAL CLINIC

Established in 2012, our on-site medical clinic provides medical care right here at The Damien Center. Patients can meet with a nurse practitioner and manage their medical needs as well as use our pharmacy technician to receive medications. The presence of the clinic also allows The Damien Center to more accurately track the HIV viral load of our clients, a key indicator of health in individuals living with HIV.

MEDICAL CASE MANAGEMENT

New in 2012 and continuing to grow, medical case management helps patients navigate their medical needs. From setting up appointments with our on-site clinic to helping patients adhere to HIV medications, our medical case manager is a direct support line for patients' medical needs.

MENTAL HEALTH SERVICES

An increased emphasis on counseling means that our HIV+ patients are better equipped to stay healthy in the face of HIV. Our licensed counselors provide a supportive, client-centered approach so patients can work toward self-sufficiency and holistic wellness. We offer:

- Mental health counseling
- Substance abuse counseling
- Psychiatry (M.D.)
- Comprehensive Risk Counseling

SUSTAIN | PROVIDING KEY SUPPORTIVE SERVICES

We believe that housing is healthcare. Our **HOUSING SERVICES** allow our clients to access safe, affordable housing and supportive services that promote stability and enhance their quality of life.

HOUSING ASSISTANCE

Safe, stable, and affordable housing offers the best opportunity for our clients to access drug therapies, treatments, and other services that will enhance their quality of life. When both HIV+ and high-risk HIV- people are housed, they can better manage other needs and become healthy and self-sufficient.

FOOD PANTRY

Meeting basic nutritional needs is critical for those living with HIV, who are already facing an often debilitating health condition and must maintain strong basic health to fight their HIV infection. By accessing our food pantry, they can keep their bodies strong.

DIRECT EMERGENCY FINANCIAL ASSISTANCE

Direct Emergency Financial Assistance (DEFA) helps clients with short-term rent, utilities, incidentals, or other one-time emergencies like car repairs or glasses.

CAREER DEVELOPMENT

Stable, long-term employment helps our clients achieve self-sustainability. Career development services provide the skills and tools they need to successfully locate and obtain stable, permanent employment.

LEGAL SERVICES

Legal services allow our clients to address needs ranging from preparing documents to accessing eligible benefits. In addition, legal staff address HIV-related discrimination or breach of confidentiality and help clients prepare for custody options of legal dependents.

DINING OUT FOR LIFE


On April 25, 2013, more than 40 local restaurants donated 25% to 100% of their day's sales to The Damien Center. Here's how it worked: there were no codes, no special menus—diners only needed to eat! Our most successful Dining Out for Life yet, the event raised nearly \$90,000 for The Damien Center and reached 10,000 local diners. In 2013, Red Lion Grog House, located in Fountain Square's historic Murphy Building, returned for the second year as a Champion Restaurant, donating 100% of April 25 sales to The Damien Center!

GRANDE MASQUERADE

The 26th Annual Grande Masquerade, The Damien Center's largest fundraiser of the year, was held on Saturday, October 19, 2013. With more than 600 guests in attendance, the event raised essential funds that allow The Damien Center to continue providing HIV preventive, medical, and supportive services completely free of charge.

VOLUNTEERS

In 2013, 271 volunteers helped us put on these events and others, keep our food pantry stocked, answer phones, reach out to our community, and much more!


