Dear Friends,

In 2015, The Damien Center enjoyed another year of growth and enrichment that would not have been possible without the generous support we received from so many members of our community. Having an engaged, dedicated donor base is vital as we continue our progress toward achieving our mission, and for that I thank you. Your generosity will continue to play a crucial role in sustaining the services required to end AIDS in our generation. Having gone to great lengths to align our services with the National HIV/AIDS Strategy, The Damien Center is committed to using the best evidence-based practices to improve the health of those living with HIV, and to connect those at highest risk of HIV infection with cutting edge prevention strategies to keep them negative.

There has never been a more exciting time to work in HIV/AIDS services. When I started in this field, nearly 30 years ago, our work was geared towards helping ease our clients' passing. Today persons living with HIV/AIDS, connected with the care they need, are healthier than ever before. We now know that lower viral loads not only lead to better health outcomes, but also reduce a person's risk of transmitting HIV to someone else. Armed with this information and the emergence of a new application of Truvada as Pre-Exposure Prophylaxis (PrEP), which studies have shown to be more effective than condom use alone for preventing HIV transmission, we finally have a reasonable path forward to not only ending AIDS, but stop the spread of HIV.

Life-saving care for persons living with HIV/AIDS and revolutionary prevention interventions for persons at risk will only be successful if the people who need them most have easy access to them. This has particularly been a concern for our hardest to serve clients, who we have seen struggle to maintain consistent care. The physical improvements to our facility completed in 2014 paved the way for the successful opening of Damien Cares in 2015, an on-site clinical partner located within The Damien Center to help address this very issue. Providing a seamless care experience between services

traditionally provided by The Damien Center, Damien Cares' impact on outcomes has already been astonishing as we see viral loads decreasing and people begin PrEP treatment and remain HIV negative.

No single service alone holds the key to addressing this decades long epidemic. It takes a village to lower a viral load, and The Damien Center will continue to transcend barriers that prevent our clients from succeeding with treatment. As you will see in the report that follows, each area of service plays a vital role in our overall goal: lowering viral loads and preventing HIV transmission. None of this would have been possible without your support; please know that your gifts continue to make a difference. The Damien Center is committed to caring for our clients until there is an end to AIDS, and I hope we can count on you to be our community partner until the end.




THE DAMIEN CENTER MISSION


HIV TESTING DEMOGRAPHICS

HIV & STI TESTING

Our free and confidential HIV and Sexually Transmitted Infections (STI) testing by state-certified staff is available both on site at the Joseph F. Miller Testing Center and at various satellite locations. We test for HIV, pregnancy, and STI's including syphilis, gonorrhea, chlamydia, and trichomoniasis.

PREVENTION OUTREACH

Our Prevention Team works to create a community that is more informed about how HIV affects us all. By providing prevention messages to clients accessing services and attending health and outreach fairs we work with the community to spread awareness about HIV.

COMPREHENSIVE RISK COUNSELING (CRCs)

Through CRCs, anyone infected with or affected by HIV/AIDS can utilize risk-reduction support in a sensitive and culturally competent environment.




LINKAGE TO CARE

Linkage to Care (L2C) provides people living with HIV in the greater Indianapolis area an extra level of individualized support so they can successfully access and stay in care. Newly diagnosed individuals have 24-hour access to support via phone, or text, to ensure successful entrance into care. The program targets HIV+ individuals who have been out of care for a year or more and provides the support they need to identify and eliminate barriers to care.




CARE COORDINATION






Client Age Groups



Client Race & Ethnicity



DINING OUT FOR LIFE

On April 30th, 2015, 54 local restaurants donated 25, 50, or 100% of their total sales to The Damien Center. This year's event raised \$107,806 for The Damien Center and reached approximately 10,000 local diners. In 2015, The Damien Center partnered with 3 restaurants that came in at the Champion level by donating 100%, 10 restaurants that came in at the Premier level by donating 50%, and 41 restaurants that came in at the Partner level by donating 25%.

GRANDE MASQUERADE

The 28th Annual Grande Masquerade: Gatsby Style, The Damien Center's largest fundraiser of the year, was held on Saturday, October 18, 2015. The event raised essential funds that allow The Damien Center to continue providing HIV prevention education, medical, and supportive services completely free of charge.


In 2015 more than 300 volunteers helped us put on special events, kept our food pantry stocked, answered phones, provided HIV awareness to the community and much more!


